GENESCO REAFFIRMS FOURTH QUARTER  
AND FISCAL 2006 GUIDANCE  
---TO WEBCAST PRODUCT TRENDS PRESENTATION AT WSA SHOW---

NASHVILLE, Tenn., Feb. 8, 2006 --- Genesco Inc. (NYSE: GCO) said today that it remains comfortable with its previously announced guidance for the fourth quarter and fiscal year 2006. Genesco plans to announce its results for the fourth quarter and fiscal year 2006 and to discuss the results and the outlook for the new fiscal year in a conference call on March 2, 2006.

The Company also announced that it would host a presentation on current product trends in its markets in connection with the WSA Shoe Show in Las Vegas. The presentation will be webcast live at 7:00 a.m. (Pacific time) on February 10, 2006, and may be accessed through the Company's internet website, [www.genesco.com](http://www.genesco.com). To listen live, please go to the website at least 15 minutes early to register, download and install any necessary software.

This release contains forward-looking statements, including the statement regarding the Company's previously announced guidance and all other statements not addressing solely historical facts or present conditions.
