GENESCO REAFFIRMS FOURTH QUARTER AND FISCAL 2005 GUIDANCE ---TO WEBCAST PRODUCT TRENDS PRESENTATION AT WSA SHOW---

NASHVILLE, Tenn., Feb. 7, 2005 --- Genesco Inc. (NYSE: GCO) said today that it remains comfortable with its previously announced guidance for the fourth quarter and fiscal year 2005. Genesco plans to announce its results for the fourth quarter and fiscal year 2005 and to discuss the results and the outlook for the new fiscal year in a conference call on March 3, 2005.
